

## COOKIE POLICY

The specific purpose of this extended statement is to explain the types and methods of use, as well as to explain what actions you can take to refuse or delete *cookies* on the website simulator.enoplastic.com (the "*Website*").

### 1. Data controller and contact details

The data controller is **Enoflex S.p.A.**, with registered office in Bodio Lomnago (VA), via Luigi Galvani 1, P.IVA and C.F. 13400560150 ("*Enoflex*" or the "*Data controller*").

### 2. Data collected

Navigation data and *cookies* (hereinafter also referred to as "*Data*").

### 3. What is a *cookie*

*Cookies* are small text strings that the Websites viWebsited by the user send to the user's terminal *browser*, where they are stored and then transmitted to the same Websites the next time the same user visits. While browsing a Website, the user may receive "first-party" *cookies* on his terminal, when they are managed directly by the Data Controller and/or operator of the Website, and also *cookies* that are sent by different Websites or *web servers* (so-called "third-party" *cookies*); this happens because the *webWebsite* viWebsited may contain elements that reside on servers other than the one on which the *webWebsite* is located. In other words, they are *cookies* that are set by a *webWebsite* other than the one you are currently visiting.

*Cookies* can be divided into three different types:

- Technical *cookies*: used for the sole purpose of enabling the Website to function properly;
- Analytical *cookies*: used to collect aggregate information of a mainly statistical nature;
- Profiling *cookies*: aimed at creating profiles on the user and used to send advertising messages in line with the preferences expressed by the user while browsing the web.

### 4. What *cookies* are used and for what purpose

With reference to the purposes pursued, the *cookies* present on the Website may be exclusively technical.

The Website uses the following *cookies* for the purposes set out below.

#### Technical cookies

The technical cookies present on the Website can be divided into: navigation or session cookies, which guarantee the normal navigation and use of the Website (allowing, for example, to make a purchase or log in to access restricted areas). These *cookies* include functionality *cookies*, which make it possible to memorise the choices made by the user on the Website (e.g. language) in order to improve the service provided to the user.

The prior consent of the users of the Website is not required for the installation of such *cookies*.

The Website uses the following technical *cookies*:

### Analytical Cookie

analytical cookies are those cookies used to gather, analyze and measure aggregated information about the user's activities on the Website.

### 5. Nature of data provision by users

The provision of Data processed through the installation of technical *cookies*, although optional, is necessary to ensure proper navigation within the Website. If you decide to disable technical *cookies*, you will not have access to many features that make this Website more efficient and some of our services will not function properly.

You can change your *cookie* preferences at any time by configuring your *browser* in accordance with the specific procedures described below. You can also use your *browser* preferences to delete *cookies* that have been installed in the past, including cookies for which you may have given your consent.

In addition, with regard to any third-party *cookies*, you may exercise your right to object to their processing by informing yourself through the third party's privacy policy, through the *opt-out* link if explicitly provided or by contacting the third party directly.

### 6. Options regarding the use of *cookies*

You can control *cookies* through your *browser* settings. As each *browser* has slightly different functions, you should check the "*help*" menu of your *browser* to find out how to correctly change your cookie settings.

You can then change your *browser* settings so that *cookies* are deleted or not stored on your computer or *mobile* device without your explicit consent. The following *links* will help you better understand how to set your *browser*:

## 7. Data recipients

The Data may be known and processed by the employees of the company functions of the Data Controller assigned to the pursuit of the above-mentioned purposes, who are expressly authorised to the processing and who have received adequate operating instructions.

Furthermore, the Data may be communicated to third parties - autonomous data controllers or duly designated as data processors - which belong to the following categories:

- external subjects operating as autonomous holders such as, by way of example, supervisory and control bodies and in general to subjects, including private ones, entitled to request the data (such as, for example, accounting consultants, legal consultants), Public Authorities who make an express request for administrative or institutional purposes, in accordance with the provisions of current national and European legislation;
- subjects outside the Data Controller who provide services to the same and who are useful for its activities (for example: suppliers of IT services for the management of *databases*, including contacts and e-mails, *providers of digital services* and IT consultants who provide technical assistance to the Data Controller, companies that offer support in carrying out market studies); these subjects have received a specific assignment as responsible for data processing and their names are available on request to the Data Controller, using the contact details indicated in Section 9 below.

## 8. Transfer of Personal Data to countries outside the European Union

Data collected on the Website will not be transferred outside the European Union.

Where this is the case, in relation to Data collected using *cookies* on the Website, the Data Controller will, to the extent of its competence, adopt appropriate safeguards, including applicable adequacy decisions and *Standard Contractual Clauses* adopted by the European Commission.

## 9. The rights of data subjects

Users, as data subjects (i.e., subjects to whom the Data refer), are holders of the rights conferred by the GDPR. In particular, pursuant to Articles 15-22 of the GDPR, data subjects have the right to request and obtain, at any time, access to their personal data, information on the processing carried out, rectification and/or updating of personal data, erasure and restriction of processing. They also have the right to object to the processing and to request data portability (i.e. to receive their personal data in a structured, commonly used, machine-readable format). Finally, data subjects always have the right to withdraw their consent at any time (this, in any case, will not affect the lawfulness of the processing carried out on the basis of the consent given before the revocation) and to lodge a complaint with a supervisory authority (in Italy: the Garante per la Protezione dei Dati Personali).
